Deposits are accepted in order to give our families the opportunity to reserve a puppy from litters. Whenever a litter is born, Deposit holders are given the first chance to pick a puppy from the litter. Pick order will be in the order deposits have been received.

Ellexson Bull Terriers reserves the right to reserve the first choice of puppy(ies) to hold back for the furthering of our breeding program.

After all Deposit holders have made their picks, we will then begin accepting full deposits on the remaining puppies.

Puppy deposits are \$150. The full deposit (\$150) will be applied towards the total purchase price of the puppy and the balance will be due in cash at the time of pickup/delivery.

At 6 weeks of age, puppies will receive their first vaccination to help protect them against highly contagious diseases like parvo and distemper. Once your puppy is chosen and as time allows, we will send photos of puppies so you can stay updated on them.**
